Managed first OLA integration test with successful signature. Work has started on integration towards Harica CA. Road forward divided into three steps. Will need further dialogue with EC to ensure we are aligned in our view going forward.

Task 2.3 - Creating a Proof of concept for eArchive services

- Indicator: Proof-of-concept by M20 (Apr 2022) and recommendation report by M23 (Aug 2023)
- Status: Ongoing
- Update: Expected to be done on time.

Task 2.4 - Usability report of eTranslate CEF building block



- Planned duration: M13 M16
- Indicator: eTranslate usability report by M16 (Dec 2022)
- Status: Delayed, but in essence ready to be published.
- Update: Final review has been done and minor issues need to be fixed, then can be published.

Task 2.5 - Student housing Web-Application



- Planned duration: M5 M12
- Indicator: Proof-of-concept by M12 (Aug 2022) and recommendation report by M23 (Aug 2023)
- Status: Delayed but work has started again.
- Update: Task is working in parallel tracks both on an updated plan of action and work has started on the actual coding of the housing web-application.

- Indicator: Recommendation report by M20 (Apr 2022)
