## How did this project come about? A few words about our previous research

The project "Academia and cultural production as 'postmigrant' fields in Sweden" received the funding by Riksbankensjubileumsfond (RJ, Dnr. P20-0137), but we are proud to mention that the funding for this project was also offered by the Swedish Research Council (VR, Dnr. 2020-01430).

The application to the Swedish Research Council required an explanation of how the project leader's previous research led to the project idea. See her reflections below, followed by a selection of former work by the other researchers in the team.

**Povrzanović Frykman**, Maja (2004). 'Transnational perspective in ethnology: from "ethnic" to "diasporic" communities', in *Transnational Spaces: Disciplinary Perspectives*, M. Povrzanović Frykman (ed.), 77–100. Malmö University.

This chapter is based on my ethnographic research-induced rejection of the 'ethnic lens' that pre-defines migrants as members of 'ethnic communities'. I instead looked at how ethnicity, but also generation, education and migration experience, inform their sociabilities. This stance is directly applicable to the research on professional trajectories in our project.

This text dwells on methodological reflections that are of crucial importance for the project. I criticized the juxtaposition of 'insider' vs. 'outsider' researchers on migrants, and exemplified the fluidity of positionalities and the negotiations of the meaning of ethnicity in research encounters.

Based on my presentation at a workshop on the future of ethnology organised by the journal *Ethnologia Europea*, this article makes programmatic claims informed by my ethnographic research on migration issues. It points to epistemological benefits of pursuing practices and experiences – a matter at the heart of the postmigrant perspective.

Research on work-life integration of refugees – some of them skilled professionals like the ones we plan to include in the project – provided me with an insight into the utmost importance of 'being seen' by a resourceful person who can help a refugee towards inclusion that is adequate to their professional experience.

The role of such similarities as the bases for professional alliances will be of central empirical interest in our project.

The concept of cosmopolitanism is often evoked in the literature on the 'postmigrant' condition that is central to the proposed project. This article is based on my long-term interest in using cosmopolitanism as a lens for understanding everyday-life encounters in which people engage in common projects and practices across ethnicity or migrant status.

I initiated this book project in order to present in one volume, the state-of-art of research in the humanities and social sciences on highly skilled migrants in Sweden. The book indicates scarcity of research on these migrants in general and on professionals in academia and cultural production in particular. Our project intends to fill this gap.
